- 5. The Amir al-Mu'minin's decrees regarding the Sharia obligations of security institutions in preventing crimes for the sake of public peace and security.
- 6. The impact of the Amir al-Mu'minin's decrees and directives in establishing appropriate administrative structures as needed and providing public services through short and simple means.
- 7. The impact of the Amir al-Mu'minin's guidance on the reform of school and university curricula within the Islamic and Sharia framework, and the preservation of Islamic values and thoughts within them.
- 8. The impact of the Amir al-Mu'minin's decrees on the lawful use of modern technologies and the control of social media and digital space.


Conference Objectives


- 1. To examine the effects of the Amir al-Mu'minin's decrees in the fields of Sharia, society, politics, economy, and culture.


Benefits of Participation in the Conference:
